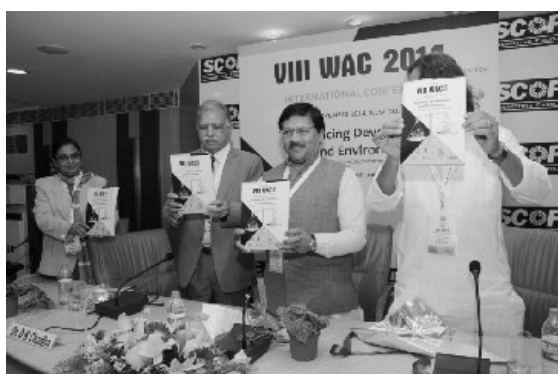


International Conference
